5. PRINCIPAL'S REPORT

Property - Work Notice

After a building warrant of fitness check, Liz needed to advise the Board there is an outstanding work notice from October 2022 relating to getting the mechanical ducting for the air conditioning checked. There needs to be proof from a qualified person and Liz is still waiting for EdPro to show a contract is in place for this. Liz will draft a letter to EdPro from the Board for Cheryl to sign.

6. SPECIAL ISSUES

Legislation - 2023 Delegations

Liz presented the "Schedule of Delegations" document. If there is a dispute, the School Trustees will ask who has delegations. This means that if Liz is away, the Deputy Principal's have authority to make decisions as listed. Liz noted the heading should be changed to "Rawhiti School Board" (remove Trustees), the "Board Chairperson" should be changed to "Presiding Member" and the final paragraph heading should read, "Delegated authority TO the Deputy Principal" (not for).

That the Board approve delegation of authority to the Deputy Principals. Carried

Enrolment Scheme Review

Liz asked for the Board to reconsider if the decision last year to not accept siblings of out of zone students due to the risk of overcrowding should be continued in 2023 or not. Factors to consider are the introduction of Aotahi has provided more space, the roll numbers are lower than previous years which affects staffing numbers and staff members children can also not be accepted as they are lower on the criteria list than siblings. This decision can be reviewed during the year if Liz considers it necessary.

Motion: Moved Cheryl

That we can accept out of zone students if they have a sibling enrolled at Rawhiti school at the time they start attending.

2022 Analysis of Variance

Liz presented a document showing some data on the target group in 2022 of students that appeared to be showing no progress over 4 data points (2 years) in reading, writing and maths. They received intensive support and there has been accelerated progress across the Manaiakalani cluster. Pasifika students' progression outperformed other groups.

Liz also discussed the Better Start Literacy data with some supporting evidence and explanation from Helen H. However it was decided that it might actually be too soon to analyse the Better Start Literacy data, taken when they turn 6 and known as 6 year nets, because some students had only had a couple of lessons before being tested, while others turned 6 at the end of the year so had more support.

2023 Annual Plan

Liz is looking for some input from the Board around what is important for "Our Community" this year as part of the annual plan, and then Liz and the staff will work on strategies to make this happen. Some points brought up included:

Liz will draft some ideas and send them out before the next meeting so some strategies can be put in place.
