Whole School Data

Liz pointed out some of the highlights of the data and some comparisons between the students in mainstream and bilingual. Liz said that the MOE has the option where you can request the support of a 'Student Achievement Function officer' (SAF) who can work alongside a school to build their own capabilities where there are gaps in the data, especially between pakeha and Maori students. It has been approved that Rawhiti will receive (a minimum of) 26 weeks of coaching and the SAF will assist with scoping the data, and then ascertaining which areas to target.
