6. SPECIAL ISSUES

Draft Strategic Plan

Rebecca Sweeney outlined the process that was taken to develop the draft plan, then presented it to the Board. Time was given for all board members to review and discuss the draft. The following feedback was given to Rebbecca who will update the draft plan to reflect these:

- Physical education and sport were in the data presented but doesn't appear in the draft. This will be added as a 4th bullet point under "expand access to creative learning opportunities including"
- Successful boxes outcomes these need to be made "less wordy"
- Our community point 3, nature based, local curriculum to be added
- Remove neurodiverse and diverse learners and say all learners

The Board agreed that the Strategic Plan would not be signed off until the amendments have been made. Depending on how quickly this happens it may be that the incoming will be required to do this.

A recommendation that the incoming Board and new Principal look at whether the RISE values are still relevant heading into the next decade.
